

## Wedding Contact- Portraits by Jeanna and Scherry

This is a legally binding contract between *Portraits by Jeanna and Scherry* and \_\_\_\_\_ (client name).

As part of this agreement, *Portraits by Jeanna* agree to provide the below checked photography services to the client on \_\_\_\_\_ (date) at \_\_\_\_\_ (time).

### *Our Traditional Series*

\_\_\_ A Simple Pleasure ... \$450. This service includes 90 minutes of pre-ceremonial photos, ceremony coverage and up to one hour of post-wedding/reception time. We shoot about 300 photos and print 100 photos for you to keep.

\_\_\_ Everyone's Favorite ... \$650. With this digital wedding package, the client will receive 90 minutes of pre-wedding photography, ceremonial coverage, return to altar shots **plus** 60 minutes of reception time. Photographers will shoot 300-500 digital photos, which you will receive on a digital photo CD. You will also receive about 150 4x5 professional edited proofs.

\_\_\_ Our Platinum Wedding ... \$850. This digital package includes an engagement session before your wedding. This session can be held outdoors or at your favorite "spot". You will receive a CD with all images plus eight of the best photos, edited. On the day of your ceremony we will offer 90 minutes of pre-wedding photography, ceremonial coverage, post-wedding shots at the church plus 90 minutes of reception time. We shoot about 600-900 digital photos, which you will receive on a digital photo CD. You will also receive about 200-250 professionally edited proofs.

\_\_\_ The Fairytale Wedding ... \$1,250. This digital wedding package gives the bride and groom an on-location engagement photo session with a cd with all of your photos. You will receive a pre-wedding consultation to discuss your customized photo schedule. This package includes 90 minutes of pre-wedding photography, ceremonial coverage, return to altar shots and up to three hours of reception coverage. We shoot 900-1200 images, which you will receive on CD. You will receive 250-300 proofs.

### *The "Everything and more" Series*

\_\_\_ **\$1000** This package includes 5 Hours coverage, a DVD w/ images to keep and a custom designed 20 page TAP "coffee table" wedding album. This package also includes an engagement session with custom designed 10 page 5x7 TAP album.

\_\_\_ **\$2000** This package includes up to 6 hours coverage and a DVD w/ images to keep. You will receive a custom designed 10x10 wedding album and two matching 8x8 parent albums. This package also includes an engagement photo session with a custom 8x8 album. Copyrights to all images are included with this package.

--- **\$2,500** This package includes up to 6 hours coverage and a DVD w/ images to keep. You will receive a custom designed 10x10 wedding album and two matching 8x8 parent albums. This package also includes an engagement photo session with a custom 8x8 album. Copyrights to all images are included with this package. Up to two hours of rehearsal coverage is included.

\_\_\_ **\$3,000** This top-notch package includes up to 8 hours coverage, in addition to two hours rehearsal coverage. You will receive a DVD w/ images to keep and a customized 10x10 wedding album and two matching 8x8 parent albums. This package includes an engagement session with a custom album. Copyrights are included with this package.

Reception time begins as soon as your photographer arrives at the reception. Additional reception time can be purchase (at the time of this contract) for \$100 an hour. Please take note that the photographers are not responsible if client does not complete all reception activities within their allotted photography time. Any additional photography time will be charged in 15 minute increments and will be added to your final bill.

There will be a travel charge for weddings and receptions more than 30 minutes from Parkersburg. If the bride/groom would like photographs taken in a location other than the wedding/reception site, this site must be approved by the photographer and additional travel expenses may incur. If the wedding and reception are held at different locations or if the reception start time is scheduled for much later than the wedding, this should be discussed prior to contract. Additional charges may apply. Engagement sessions will be held in the Parkersburg/Vienna area, unless another location is discussed and agreed upon at time of contract. Additional travel expenses for other locations may apply.

Each package guarantees one photographer, however we will send two when our schedule allows. You may request a "guaranteed" second photographer at the rate of \$100 per wedding, at time of contract. **During events that include meals, the photographer(s) should be included in your final meal counts.**

A non-refundable deposit of \$150 is required reserve your wedding date. A second non-refundable deposit of 50 percent of your remaining balance is due one month prior to your wedding. The remaining balance is payable when your proofs arrive, which is usually within two weeks of your wedding. Non-payment or cancellation prior to wedding will result in void of contract and will result in loss of reservation and all deposits paid. Late payment following wedding will incur a \$10 per week additional charge.

Proofs are copyrighted and images cannot be reprinted without written consent from the photographer. Copyrights are available for purchase of \$100. A reprint price guide has been provided to the client online at [www.portraitsbyjeanna.com](http://www.portraitsbyjeanna.com). Client is advised to print reprint prices at time of contact from website, as prices listed at time of booking are guaranteed for at least 60 days following your wedding.
